### BACKGROUND INFORMATION:


The Commission is appointed by the City Council. It recommends plans for the regulation of future growth, development and design of the City, and carries out the provisions of the General Plan and the Zoning Ordinance.

- This Commission meets on the first and third Tuesday of each month at 7:00 p.m. in the City Council Chambers.
- Applicants for this Commission must reside within the city limits.
- Planning Commission Members receive compensation in the amount of \$200 per month.
- Three vacancies, (three vacancies due to term expirations on 12/31/2016)
- Applications must be received by **5:00 p.m. on Friday, December 2, 2016**

As required by State and local law, all members appointed to the Planning Commission are required to file a Statement of Economic Interests, Form 700. Items that must be disclosed on the Statement of Economic Interests include: interests in real property located within the city limits or within two miles of the city limits, or within two miles of any land owned or used by the City; and investments and business positions in all business entities and income, including loans, gifts, and travel payments from all sources. This document is a public record subject to disclosure.

Your application can be submitted in person at the City Clerk's office located on the 3<sup>rd</sup> Floor of City Hall at 150 City Park Way, e-mailed to [cityclerk@brentwoodca.gov](mailto:cityclerk@brentwoodca.gov), or via Fax to (925) 516-5441.
