1. **PURPOSE**

The purpose of this policy is to establish guidelines for public users of the City's free Wi-Fi Service.

In order to access the Wi-Fi Service, each user will be required to agree to the terms and conditions of use. The terms and conditions require the user to comply with all applicable Federal, State and local laws, rules, regulations and ordinances regarding use of the service and of the internet.

2. **POLICY**

- 2.1 <u>Terms and Conditions:</u> Each user is required to agree to terms and conditions which will be considered a binding agreement between the user and the City of Brentwood.
- 2.1.1 The terms and conditions may be amended by the Director of Finance and Information Systems or his/her designee in consultation with the City Attorney.
- 2.2 **Personal Use Only:** The Wi-Fi Service provided will be for personal use only. The Wi-Fi Service is not intended for business use or to be a resident's primary internet service.
- 2.3 Management of Use: The Information Services division of the Finance and Information Systems Department will manage the Wi-Fi Service. The Wi-Fi Service will be implemented with a program that includes a timed user session mechanism. The program will enable shutdown by the system of a user's access if a user monopolizes the system for longer than two hours in any given day. The user can gain access to the system the following day. Sessions will not be limited during City Council meetings to enable the public to have internet access during the meetings. Such sessions will be timed out at midnight or upon the adjournment of the City Council meeting, whichever is later.
- 2.4 **Availability:** The Wi-Fi Service will automatically shut down for the day at 11:00pm and restart at 7:00am.

3. PROCEDURE

3.1 <u>Use:</u> In order to gain access, each user must select the City's Wi-Fi-public network, by doing so, the user will be directed to the "City of Brentwood Welcome to our Wi-Fi" page.

The user shall read the terms and conditions, and by selecting the "Agree" button, the user agrees to be bound by the terms and conditions of use. The user will be issued an IP address and gain access to the Wi-Fi Service.

3.2 **Disclaimer:** The terms and conditions include a disclaimer which states that the Wi-Fi Service is provided "as is" and shall be used at the user's own risk.

It is the responsibility of each user to protect their computer and the City of Brentwood shall not be held liable and assumes no responsibility for any direct or indirect damage arising from the use of the Wi-Fi Service.

- 3.3 <u>Changes to or Termination of Service:</u> The City of Brentwood may modify or terminate the City's Wi-Fi Service or the terms and conditions, for any reason, without notice. Upon termination of the Wi-Fi Service, any and all rights granted by the City to user shall terminate.
- 3.4 **Privacy Protection:** All users tracking logs will be purged from the system every evening.

USE REQUIREMENTS

The user agrees not to do any of the following:

- Use the Wi-Fi Service in a manner which violates applicable laws;
- Interfere with or disrupt network users, services or equipment, including distribution of unsolicited advertising, propagating computer worms or viruses, and using the network to make unauthorized entry to other computers.
- Transmit any material that threatens or encourages bodily harm or destruction of property or harasses another individual.
- Sell or buy products, items, or services to advance any type of a financial fraud such as "pyramid", "ponzi" and/or "chain letters."
