ment of decent housing and a suitable living environment for every Californian is a priority of the highest order. The City of Brentwood understands the need for affordable housing opportunities. The City of Brentwood's Housing Division is continuously working with non-profit, private, and public entities to maximize opportunities to develop affordable housing.

The City of Brentwood's Affordable Housing Program seeks to make decent,



sanitary and safe housing available to Brentwood residents, workers, and all eligible participants.

INCOME GUIDELINES

Affordable units are available to those households who qualify as first time homebuyers; very low income, low income, or moderate income.

Income information is received by the State of California, and may change each year. Please contact the City's Housing Division for the most current information.

PRIORITIES FOR ELIGIBILITY (AFFORDABLE HOUSING PROGRAM)

The City's affordable housing program is open to all eligible households. The City has adopted a priority status for the following categories of households:

- Brentwood Emergency & School District Personnel
- Brentwood Residents who have lived in the City limits for at least six months;
- Brentwood Workers who are employed full-time (40 hrs/week) within the city limits (this may include non-residents)
- All other households with eligible incomes.

PROCESS FOR ELIGIBILITY

- Fill out application for interest/wait list —applications are accepted for “open” lists only. An income and employment verification will be conducted;
- Select names from eligible categories;
- Take mandatory City sponsored seminars;
- Move to eligibility list for future purchase of unit.

Participants are required to obtain financing from a City of Brentwood “preferred lender”. (Please see reverse side for the list of preferred lenders.)
