



Brentwood Housing Statistics June 2018 Report

Summary:

The housing data contained in this report reflects information reported for the month of June 2018. The number of active units on the MLS for June 2018 was 130. Pending units for June 2017 through June 2018 ranged from 155 down to 143. The total units sold during June 2017 through June 2018 was 1160; a total of 108 sold for the month of June 2018. Compared to the total units sold in June 2017, 2018 saw the same amount of units sold. June 2017 through 2018 has shown a continued increase in home values. Distressed home sales for June 2018 were 2% of the total homes sold.

The average sold price for June 2018 was \$633,574. The median asking price for June 2018 was \$681,950, and the median sold price was \$589,000. In June 2017, the median sold price was \$78,000, in 2016 it was \$550,000 and in 2015 it was \$508,000.

Definitions:

Notice of Default (NOD)

A publicly recorded notice that a property owner has missed scheduled loan payments for a loan secured by a property. Some states require lenders to record a notice of default to begin the foreclosure process

Notice of Trustee Sale (NOT)

A document announcing the public sale of a property to recover a debt owed by the owner of the property. The notice is mailed to parties affected by the sale of a property, advertised in local publications and recorded in public records. Among other information, it provides the date, time and location of the sale.

Real Estate Owned (REO)

This status indicates the property is now owned by the lender or bank as a result of an unsuccessful sale at a foreclosure auction.

Short Sales

A process in which the bank or mortgage lender agrees to discount a loan balance due to an economic hardship on the part of the mortgagor/homeowner. A short sale is typically executed to prevent a foreclosure.
