



Brentwood Housing Statistics January 2020 Report

Summary:

The housing data contained in this report reflects information reported for the month of January 2020. The number of active units on the MLS for January 2020 was 125. Pending units for January 2019 through January 2020 ranged from 66 to 70. The total units sold during January 2019 through January 2020 was 1043; a total of 48 sold for the month of January 2020. Compared to the total units sold in January 2019, 2020 saw a slight increase in the amount of units sold. January 2019 through 2020 has shown a continued increase in home values. Distressed home sales for January 2020 were 0% of the total homes sold.

The average sold price for January 2020 was \$670.357. The median asking price for January 2020 was \$675,000 and the median sold price was \$621,500. In January 2019, the median sold price was \$630,000, in 2018 it was \$574,000 and in 2017 it was \$574,475.

Definitions:

Notice of Default (NOD)

A publicly recorded notice that a property owner has missed scheduled loan payments for a loan secured by a property. Some states require lenders to record a notice of default to begin the foreclosure process

Notice of Trustee Sale (NOT)

A document announcing the public sale of a property to recover a debt owed by the owner of the property. The notice is mailed to parties affected by the sale of a property, advertised in local publications and recorded in public records. Among other information, it provides the date, time and location of the sale.

Real Estate Owned (REO)

This status indicates the property is now owned by the lender or bank as a result of an unsuccessful sale at a foreclosure auction.

Short Sales

A process in which the bank or mortgage lender agrees to discount a loan balance due to an economic hardship on the part of the mortgagor/homeowner. A short sale is typically executed to prevent a foreclosure.
