



Brentwood Housing Statistics September 2020 Report

Summary:

The housing data contained in this report reflects information reported for the month of September 2020. The number of active units on the MLS for September 2020 was 88. Pending units for September 2019 through September 2020 ranged from 127 to 162. The total units sold during September 2019 through September 2020 was 1062; a total of 111 sold for the month of September 2020. Compared to the total units sold in September 2019, 2020 saw an increase in the amount of units sold. September 2019 through 2020 has shown home values to be steady. Distressed home sales for September 2020 were 1% of the total homes sold.

The average sold price for September 2020 was \$700,799. The median asking price for September 2020 was \$746,606 and the median sold price was \$660,000. In September 2019, the median sold price was \$626,198, in 2018 it was \$593,000 and in 2017 it was \$570,000.

Definitions:

Notice of Default (NOD)

A publicly recorded notice that a property owner has missed scheduled loan payments for a loan secured by a property. Some states require lenders to record a notice of default to begin the foreclosure process

Notice of Trustee Sale (NOT)

A document announcing the public sale of a property to recover a debt owed by the owner of the property. The notice is mailed to parties affected by the sale of a property, advertised in local publications and recorded in public records. Among other information, it provides the date, time and location of the sale.

Real Estate Owned (REO)

This status indicates the property is now owned by the lender or bank as a result of an unsuccessful sale at a foreclosure auction.

Short Sales

A process in which the bank or mortgage lender agrees to discount a loan balance due to an economic hardship on the part of the mortgagor/homeowner. A short sale is typically executed to prevent a foreclosure.
