CONSTRUCTION NOISE ORDINANCE

Brentwood Municipal Code 9.32.050 – PROHIBITED SPECIAL NOISE SOURCES

- ❖ **Outside Heavy Construction** (heavy earth moving equipment) work is allowed as follows:
 1. Monday through Friday between the hours of 7:00am to 3:30pm, or until 5:30pm with City Engineer’s approval,
 2. Saturday from 8:00am to 5:00pm with City Engineer’s approval,
 3. No work allowed on Sundays and City Holidays.
 - i. Exception: The performance of emergency work.

- ❖ **Outside Carpentry Construction** (building construction) work is allowed as follows:
 1. Monday through Friday between the hours of 7:00am to 7:00pm,
 2. Saturday from 9:00am to 5:00pm,
 3. No work on Sundays and City Holidays.
 - i. Home repairs, lawn mowing, gardening and routine maintenance of personal property is not considered construction.
