

# NEW COMMERCIAL SUBMITTAL AND APPROVAL REQUIREMENTS

Effective:June 1, 2014 Revised: January 24, 2024

### **GENERAL:**

- Signature on all documents by person preparing plans and documents.
- Name, title and registration number of design professional, if applicable, address and phone number.
- Cover sheet information with applicable codes and editions and all design review conditions of approval.

## **NEIGHBORHOOD SERVICES - PLANS SHOULD INCLUDE:**

- (Three (3) sets) Architectural and structural, plans (including all plumbing, electrical, mechanical and CalGreen checklist). Two (2) sets must be wet stamped.
- (Two (2) sets) Structural calculations
- (Two (2) sets) Truss calculations w/EOR approval letter
- (Two (2) sets) Energy calculations
- (Two (2) sets) Soils Report
