Overview

Due to recent State of California regulations on water usage, prior to receiving a building or grading permit, applicants must submit a completed Landscape Project Application for:

- 1. new construction projects with an aggregate landscape area equal to or greater than 500 square feet requiring a building or landscape permit, plan check, or design review;
- 2. rehabilitated landscape projects with an aggregate landscape area equal to or greater than 2,500 square feet requiring a building or landscape permit, plan check, or design review;
- 3. existing landscapes installed before December 1, 2015, and are over one acre in size.

Submittal Requirements

No application will be accepted for processing until the information listed below is submitted to the satisfaction of the Community Development Department:

- 1. One copy of the completed Universal Application.
- 2. One copy of the completed Landscape Project Application. Please note that Appendix C, Certificate of Completion, is to be submitted at the conclusion of the project.
- 3. The required application fee.
- 4. A detailed landscape plan map drawn to scale showing the site and including north arrow.
- 5. All above materials in an electronic format.
- 6. Additional information as deemed necessary by the Community Development Department.

Processing Time

Landscape project applications are typically processed in 1-2 months, depending on the number of revisions required. After a review of the application, the Community Development Department will be able to provide further clarification on the expected time required for processing.

Public Hearings Required

No public hearings are required.

Appeal Process

Decisions made by either the Zoning Administrator or Planning Commission are subject to appeal, in accordance with Chapter 17.880 of the Brentwood Municipal Code. In general, decisions of the Zoning Administrator become effective 10 calendar days after they are made. Any affected party may appeal a decision of the Zoning Administrator to the Planning Commission by submitting an application and the required appeal fee to the City Clerk during the 10-day appeal period. Decisions of the Planning Commission also become effective 10 calendar days after they are made. Any affected party may appeal a decision of the Planning Commission to the City Council by submitting an application and the required appeal fee to the City Clerk during the 10-day appeal period. Decisions of the City Council are final.
