The City has until September 18, 2017 to initiate activities consistent with the development of the property for low and moderate housing purposes. Actions occurred prior to September 18, 2012, but there have been no additional actions since that date.

NOTE: Section 34176.1 ( e ) which states that "With respect to interest in real property acquired by the former redevelopment agency prior to February 1, 2012, the time periods described in Section 33334.16 shall be deemed to have commenced on the date the Department of Finance approved the property as a housing asset. The DOF approved the transfer of all real property holdings, as described in item 4 above, on September 18, 2012.

NOTE: subparagraph (B) of paragraph (3) of subdivision (a) states: If the housing successor fails to comply with the extremely low income requirement in any five-year report, then the housing successor shall ensure that at least 50 percent of these remaining funds expended in each fiscal year following the latest fiscal year following the report are expended for the development of rental housing affordable to, and occupied by, households earning 30 percent or less of the area median income until the housing successor demonstrates compliance with the extremely low income requirement in an annual report described in subdivision (f)

A total of 160 out of 338 units are restricted for senior and assisted living purposes. This equates to 47.3% of all deed restricted units from the prior 10 years. These figures do not include units funded by the City's inclusionary housing program.
