Response Times

CALLS FOR SERVICE ARE PRIORITIZED INTO TWO GENERAL CATEGORIES:

PRIORITY 1 - CALLS FOR SERVICE INVOLVING AN IMMEDIATE THREAT TO LIFE OR CRIMES THAT ARE IN PROGRESS.

PRIORITY 2 – CALLS FOR SERVICE THAT ARE A HIGH PRIORITY BUT DO NOT ELEVATE TO THE LEVEL OF AN EMERGENCY.

Definitions

AGGRAVATED ASSAULT – WHEN A BATTERY IS COMMITTED AGAINST ANY PERSON AND SERIOUS BODILY INJURY IS INFLICTED ON THE PERSON, OR A DEADLY WEAPON IS USED.

■ SIMPLE ASSAULT – WHEN A BATTERY IS COMMITTED AGAINST ANY PERSON THAT DOES NOT AMOUNT TO SERIOUS BODILY INJURY, AND A DEADLY WEAPON IS NOT USED.
