Per Health and Safety Code 33334.16, the City had until September 18, 2017 to initiate activities consistent with the development of property for low and moderate income housing purposes. Although this date has passed, the City continues to pursue options for development of this parcel for low and moderate income housing purposes. No additional interest in real property has been acquired since September 18, 2012.
