PARK & RECREATION COMMISSION REGULAR MEETING

CALL TO ORDER: Chair Frey called the meeting to order at 7:00 p.m.

ROLL CALL: Chair Trevor Frey, Vice-Chair Kevin Peltz and Commissioners Noman Cohen and Blythe Lind were present. Commissioner Bullington was excused. Staff members present were Kris Farro, Recreation Manager, Joe Odrzywolski, Parks Planner; Aaron Wanden, Park Maintenance Manager; Jason Coll, Park Maintenance Supervisor and Elaine McGurk, Administrative Supervisor.

A. PRESENTATIONS:

1. Eagle Scout Project by Patrick Breves. (J. Coll)

Jason Coll, Park Maintenance Supervisor, introduced an Eagle Scout Project by Patrick Breves. Patrick Breves, a Boy Scout, presented his Eagle Scout Project to the Commission. He plans to plant three 15-gallon Chinese Pistache trees outside Veterans Hall on First Street. There will also be flowers added to areas around the building that are barren.

B. INFORMATIONAL REPORTS FROM COMMISSIONERS, SUBCOMMITTEES, LIAISONS AND STAFF

Commissioner Lind attended two ad-hoc committee meetings (Arbor Day & Restrooms at Creekside & Garin Park).

Vice-Chair Peltz attended two ad-hoc committee meetings (Restrooms at Creekside & Garin Park and Parkside Villas)

Commissioner Cohen attended the Arbor Day ad-hoc committee meeting with Commissioner Lind and Jason Coll.

Joe Odrzywolski, Parks Planner reported the following:

- On March 8, 2022, Towhee Park went to City Council for acceptance of park and landscaping improvements.
- The Vineyard Project is moving along swiftly. Aspen and Monte Rosa Parks are in the 90-day maintenance period and will be accepted in early July.
- At Alta Park, the hardscape and play structure will be installed in the next few weeks.
- Shea Homes will begin to start a section of trail that will connect to the Marsh Creek Trail.

Aaron Wanden, Park Maintenance Manager, gave an update on an email received in regards to adding dog wastebaskets on the corners of Garin Parkway/Chestnut Street and Garin Parkway/Balfour Road. Aaron said staff is reviewing the matter and will determine if it would be feasible.

Kris Farro, Recreation Manager Reported the following:

- Sports and Adult Softball are active and in full swing.
- Bingo at the Senior Center will return. This activity is in partnership with the Brentwood Senior Club. At this time, the Senior Club Board is requesting for proof of vaccination and not a requirement of the City.
- The Contra Costa Nutrition Food program CC Café changed its name to Café Costa. They started something new on Tuesday and Thursday, they are serving food from Chapala Restaurant. They are trying to be culturally inclusive with the type of meals served. With more funding, they hope to include a diverse array of foods.
- Arts Commission approved for seven new utility boxes art projects and a Call for Artwork at the Library is out.
- Brentwood Community Center will be getting the carpet replaced.
- Summer 2022 Activites Guide will be out in the next couple of weeks.
- Concerts in the Park will be back this summer.
- On March 29th the new City website will go live.
- Recreation is hiring for seasonal and part time positions.

D. SCHEDULED MATTERS

1. **INFORMATIONAL ITEM**: Staff update on the BETC/BSAC Conceptual Plan Study. (K. Farro)

Kris Farro, Recreation Manager, introduced the item. A bid for architectural firm went out to evaluate the Brentwood Technology Center for a possible Youth Center and the Expansion of the Senior Center. Dreyfuss & Blackford was selected and after some structural & seismic assessment at the Brentwood Technology Center, it was determined that many modifications would need to be made. There is not enough ceiling height to transform the building into a gymnasium. The Brentwood Technology Center will not be a possible site for a Youth Center.

A survey went out to the youth and the parents of the youth to inquire what desires they have for a youth center. Some things they would like to see are academic activities, a lounge area, a cooking space, a place to do art, a gaming area, and recreation area.

The Expansion of the Senior Center and Youth Center will be included on a long-term project list. The City Council has moved the Sand Creek Sports Center to the top of the strategic initiatives list.

The City Council is looking into County funds for the establishment of a Youth Center and will apply for the funds once the application is available.

2. **ACTION ITEM**: Consideration of direction of staff to review current cost recovery model and research other models to determine best practices. (K. Farro)

Kris Farro, Recreation Manager, introduced this item. Staff is in the process of reviewing the cost recovery and fees for recreational programs. Currently the established fees does not allow for any free or subsidized programming. Staff would like to evaluate the "best practices" for establishing fees to be inclusive for all family.

Other agencies have used the tier model. This method would allow for any entry level or introductory class (lowest tier) to be free or heavily subsidized and specialized classes (highest tier) would not subsidized.

The Commission discussed this topic and agreed to have staff look more into the tier system for the City recreation program fees.

3. <u>ACTION ITEM</u>: Approve the City of Brentwood Arbor Day Event on Saturday, April 30, 2022 (J. Coll)

Jason Coll, Park Maintenance Supervisor, met with the Arbor Day ad-hoc committee (Commissioner Cohen & Lind) on March 4, 2022. Jason said the plan is to plant 20 plus trees at Blue Goose Park on April 30th

This will also be the 12th year that the City qualifies to be designated as a Tree City USA.

Accept Parks Division Quarterly Report

Parks Maintenance

- Parks staff tested (35) backflow prevention devices in the parks.
- > Parks staff has been removing graffiti almost daily at City Park, Brentwood Skate Park and Balfour-Guthrie.
- ➤ Parks staff rebuilt the City Park water feature filters in preparation for the spray pad to open April 1st.
- Parks staff got all pump systems for the City's spray pads operational in preparation for the April 1st start date.
- Parks staff converted all bollard lights at City Park to LED lights.
- Parks staff repaired multiple issues at the Oak Meadow restrooms toilets in both Men's and Women's restrooms.
- > Parks staff removed many downed trees from various rain/storms this winter.
- Landscape contractors installed 2 new memorial trees in the parks.
- Parks staff removed 18 dead trees in various parks.
- Parks staff replaced multiple sections of sidewalk at King Park.
- Parks staff measured out and striped all sports fields at Sunset, Balfour Guthrie, Oak Meadow and Garin Park.
- > Parks staff renovated all baseball fields for the season.

Playground Maintenance

- Construction of the new playground at Blue Goose Park (CIP) is complete and opened to the public.
- ➤ Park Maintenance staff has completed 32 Work Orders in regards to playground related issues.
- ➤ Park Maintenance staff completed over 100 scheduled playground inspections for the quarter and made all corrections to minor maintenance issues.

➤ Parks staff replaced various playground parts due to vandalism at Mission Grove, Spirit, Celeste, Granville Green and Walnut Park.

LLD Maintenance

- ➤ Park Maintenance staff installed new lettering to the 'Welcome to Historic Downtown Brentwood' sign at the corner of Oak Street and Brentwood Blvd near the Chevron gas station.
- ➤ Park Maintenance staff removed and replaced a section of sidewalk on Concord Ave in order to repair an irrigation leak that was under the sidewalk.
- ➤ Parks staff completed 10 grinding of tree stumps from dead or removed trees in preparation for new plantings.
- ➤ Parks staff and landscape contractors completed over 66 work orders regarding the landscape and irrigation throughout the city's LLD's.
- Landscape contractor completed many plant replacements in LLD 03-2 along O'Hara Ave.
- > Parks staff removed many trees in LLD 97-1 in preparation for new plantings.

Accept Parks Division Quarterly Report

LLAD/R-Area Maintenance/Trees

- ➤ Landscape Maintenance contractors corrected approximately 7 Out of Compliance notifications for landscape deficiencies throughout various R-Areas.
- ➤ Landscape Maintenance contractors completed 49 work orders related to and R-Area landscape maintenance issues.
- ➤ Park Maintenance staff stumpground 17 tree stumps around the city in effort to save money in the contingency of the tree maintenance contract.
- ➤ City landscape maintenance contractors replaced 41 plants and 38 trees that failed throughout the city.
- ➤ Park Maintenance staff removed 23 dead Redwood trees and stumpground the stumps in preparation for the City of Brentwood's Arbor Day event.
- ➤ Park Maintenance staff removed 2 old irrigation controller pedestals that rusted and created a hazard. They were replaced with new stainless steel enclosures that are now up to the City's landscape maintenance standards.
- ➤ Park Maintenance crew and supervisors have been working on cleaning up overgrown trees and debris in weed abatement areas to help prevent homeless encampments throughout the city.
- Park Maintenance staff continues to work with Solid Waste, Streets, Water and Community Enrichment on the citywide tree matter to ensure they are up to the City of Brentwood's municipal codes.
- ➤ Park Maintenance staff is working on correcting the effects of the City's non-potable water on the soil and plant health. The Park Maintenance Supervisor is working with different soil amendments and maintenance techniques that could minimize the negative effects caused by irrigating with non-potable water.
- ➤ Park Maintenance staff continues to respond to emergencies, remove, trim and maintain the City's 30,000+ trees in effort to alleviate the high cost of tree maintenance on the City of Brentwood.

Background

On October 9 and 10, 2019 the City Council participated in a strategic plan workshop to discuss the City of Brentwood draft Strategic Plan FY 2020/21 – FY 2021/22, and to direct staff on various initiatives. The City Council received financial information related to the City's financial capacity and identified resources to fund the two-year strategic plan. During the workshop, the City Council discussed, reviewed, and provided staff with direction on various initiatives.

On February 25, 2020, the City Council adopted Resolution 2020-29 to a) adopt the City of Brentwood Strategic Plan FY 2020/21 – FY 2021/22, and b) direct staff to incorporate strategic plan costs into the Operating and Capital Improvement Program (CIP) Budgets, as well as in the City's ten-year General Fund Fiscal Model. The Strategic Plan included the following initiative in Focus Area 5: Community and Neighborhood Services:

- 1. Implement short-term high priority Parks and Recreation Master Plan projects:
 - c. Increase Sunset Park Athletic Complex hours of operations

On May 26, 2020, the City Council conducted a workshop on the draft 2020/21 – 2021/22 Operating Budget and draft General Fund Fiscal Model.

On June 23, 2020, the City Council adopted Resolution 2020-85 amending the 2019/20 Operating Budget and adopting the 2020/21 – 2021/22 Operating Budget.

On July 14, 2020, the City Council adopted Resolution 2020-96 to amend the City of Brentwood Strategic Plan FY 2020/21 – FY 2021/22. The Strategic Plan included the following initiative in Focus Area 5: Community and Neighborhood Services:

1. Implement short-term high priority Parks and Recreation Master Plan projects:

e. Increase Sunset Park Athletic Complex hours of operations

On January 26, 2021, the City Council adopted Resolution 2021-15 amending the 2020/21 Operating Budget; approving the recommended mid-year budget adjustments; and amending the 2020/21 – 2024/25 Capital Improvement Program (CIP).

On February 9, 2021, the City Council received an update on the Amended City of Brentwood Strategic Plan FY 2020/21 – FY 2021/22 and Funding Deferred Projects Holding List.

Provide direction to staff regarding the park acreage requirement for the 7590 and 7650 Lone Tree Way project, Subdivision 9597, a proposed 38-lot single-family

residential subdivision.

Staff is seeking direction from the Commission as to whether this project should include a park dedication and build a park with the project at the General Plan prescribed rate of 5 acres per 1000 residents, or pay in-lieu fees (fee out) per the Development Fee Program.

Seecon Financial and Construction Company is proposing a 38-lot single-family residential subdivision at 7590 and 7650 Lone Tree Way, a 16.3 acre site. With the official application submittal made to the Planning Department recently, no park dedication is proposed by the developer currently and the project as proposed would pay an in-lieu fee of approximately \$435,000 in Development Impact Fees for Parks and Trails. See thee attached Vesting Tentative Map Exhibit.

Staff has concerns about the project not providing equitable park access for the project's new residents and is considering requiring the project to dedicate the requisite park acreage, approximately 0.60 acres of park, within the project. The project's location would require new residents to travel a distance of almost a half-mile (2,640 feet) AND cross the busy arterial streets of Lone Tree Way or O'Hara Avenue in order to access existing parks. Per the 2019 Parks, Trails and Recreation Master Plan, in determining park dedication requirements for new development, residents of the new development should have easy, safe access to an existing park within a half-mile walk. See attached exhibit and summary below.

Portofino Park – 2000+ feet, requires crossing Lone Tree Way at either O'Hara or Adams Lane, lacks sidewalks in some areas along Lone Tree Way. Passive park with no play structure.

Steeplechase Park – 2000+ feet, requires crossing O'Hara, lacks sidewalks in some areas along Lone Tree Way. Does include play structure.

Pistachio Park – 2000+ feet, requires crossing O'Hara, lacks sidewalks in some areas along Lone Tree Way. Does include play structure.
