

Introduction

All signs at **Valdry Court Business Park** are to be controlled by this Master Sign Program (MSP). The MSP will contribute to the vitality and purpose of **Valdry Court Business Park**, and has been designed to enhance the image of the center.

All signs in the center must conform to the signage guidlines and specifications set forth, and are to be submitted to the Architectural Committee/Association of *Valdry Court Business Park*.

The Architectural Committee/Association of *Valdry Court Business Park* is responsible for final approval of all sign designs, prior to submittal to the City of Brentwood..

Submittal requirements: Drawings are to depict copy size, letter style, colors & overall copy area within the visible area of the signs. All drawings will be to scale showing any and all new signage on the fascia. (Minimum scale accepted 1/8"=1'-0").









Image Objectives

The Purpose of this sign program is to ensure that the integrity of the signage at **Valdry Court Business Park** is presented with uniformity, while still serving the objectives of **Valdry Court Business Park**.

This program has been established for the benefit of the Owners, the Association and the tenants of *Valdry Court Business Park*. These guidelines will provide visual consistency and promote an image of quality, that unites all individual tenants of *Valdry Court Business Park*.

The Guidelines will establish minimum standards that are compatible with the image and objectives of Valdry Court Business Park.

It is the responsibility of each tenant/owner to submit design drawings of the proposed sign "insert" to the Owner/Association and the City of Brentwood prior to installation of any signage.









Sign Factors

- All Tenant Signs will be a single faced, 1/8" thick metal panels with horizontally brushed Aluminum finish.
 The copy on the sign to be computer cut opaque vinyl.
- 2. Each aluminum sign will be attached structurally to building parapet fascia by 1/4" diameter x 3" long threaded rod welded to back of sign panel and installed into drilled holes in the existing wall fascia.
- 3. The size of each aluminum sign shall be 2'-0" x 8'-0" with radius Ends.

 Signs to have a depth of 1/8". All attachment bolts and clips must be non-corrosive.
- 4. All copy, logos and graphics to be out of opaque burgundy vinyl 3M 225-58. All signs to have the same 1" border.
- To ensure visual integrity to the Business Park, the design copy/ logo for all inserts (faces) will be subject to review by the management/Association. Complete shop drawings indicating copy and logo dimensions shall be submitted in color to the City of Brentwood for consideration of permits.










Miscellaneous

- A. No individual letter construction will be allowed in order to maintain center architectural aesthetics.
- B. Roof signs, exposed conduit & raceways, are prohibited.
- C. No flashing, moving, rotating or audible signs will be allowed.
- D. Wording on signs shall be limited to the business name and logo.
- E. After the Sign installation is complete, the sign contractor is obligated to request a final inspection by the City of Brentwood.
- F. No sign shall be painted directly on walls or surface of any building, including windows.
- G. No Banners, pennants, or temporary signage is to be placed on or around any building without the permission of Management/Association & the City of Brentwood. (Subject to an approved banner sign permit).
- H. Tenants are allowed one (1) informational sign at the main entry to their occupied space. This sign is reserved for business name, logo, business hours & emergency Phone numbers. The copy for this sign is to be machine cut vinyl, applied to the office window/door glazing. The maximum area for this sign is 2 square feet. The maximum letter height on business name & logo shall not exceed three (3) inches. All other letter heights are not to exceed one (1) inch.
- I. Tenants are allowed to post business name only on the rear entry door (not the roll-up) to warehouse area of occupied space. Maximum letter height shall not exceed one and one half inches (1½").












Brentwood, California MASTER SIGN PLAN




Single Face, non Illuminated Wall Mounted Fabricated Aluminum Signs.

Signs To Be A Maximum Of 24" In Height. Length Of signs Are To Determined By Individual Tenant's Leased Space. Tenants Are Allowed ½ Ft For Each Linear Footage Of Lease Space (ie; 20 Ft Frontage = 10 Ft Long Cabinet), With A 25 Ft Maximum Length.

Signs Will Be Centered Over Individual Tenant Leased Space Horizontally, And itered On Fascia Vertically. (equal Amounts Of Space Above And Below Sign). Signs wust Be Mounted To Fascia Area Only.

Signs Must Be Mounted To Fascia W/ Non-corrosive Attachment Hardware Only.

External Means Of Sign Illumination Are Allowed.




Brentwood, California MASTER SIGN PLAN
