2. Telephone

The request must contain in the subject line "Request to Speak – Agenda Item #" and should include name and full phone number that will be used to call in. PARK & RECREATION COMMISSION REGULAR MEETING

CALL TO ORDER: Chair Frey called the meeting to order at 7:00 p.m.

ROLL CALL: Chair Trevor Frey, Vice-Chair Kevin Peltz and Commissioners Derrick Bullington, Noman Cohen and Blythe Lind were present. Staff members present were Ben Keisic, Recreation Supervisor, Joe Odrzywolski, Parks Planner; Aaron Wanden, Park Maintenance Manager; and Elaine McGurk, Administrative Supervisor.

PUBLIC COMMENTS: NONE

A. INFORMATIONAL REPORTS FROM COMMISSIONERS, SUBCOMMITTEES, LIAISONS AND STAFF

Commissioner Cohen: He attended an Ad-Hoc Committee meeting with Commissioner Bullington and Joe Odrzywolski, Parks Planner regarding trail improvements.

Commissioner Lind: Attended the Blue Goose Park ribbon cutting and assisted with the Youth Commission interviews. The kids were all very impressive and did a great job.

Commissioner Bullington: He attended the same meeting at Commissioner Cohen.

Aaron Wanden, Park Maintenance Manager reported the following:

- City Council approved on Tuesday, April 26, 2022 the restroom project at Creekside and Garin Parks, Sunset Park Playground replacement, and the Deer Ridge Frontage Landscaping Improvements Project.
- Arbor Day event is planned for Saturday, April 30 at Blue Goose Park. Earth Day will also be celebrated at Blue Goose Park, Balfour Guthrie and Sunset Park. The event starts at 9:30. Boondoggies at Sunset Park at will provide lunch around 11:30 am. Jun Gandia, Recreation Coordinator, and camp staff will oversee the kids' games and activities at Sunset Park.
- Participants can also register on-site if they did not pre-register.

Ben Keisic, Recreation Supervisor reported the following:

- There are 63 registered for Arbor Day event so far.
- The Summer Activities Guide is out.
- The Arts Commission selected a Poet Laureate and in May will go to City Council for approval.
- There is a current recruitment for a Youth Poet Laureate.
- City Council approved the revised BNC guidelines and the Park and Recreation Commission will hold the interviews in the near future.

- Movie in the Park on April 22 featured Onward.
- Movie in the Park on May 20 will feature Encanto.
- On May 14, the Brentwood Family Aquatic Complex will open for recreation swim.
- Currently there are 180 registrations for the Junior Giants; the program can take up to 300 registrants.
- ON June 17, the Youth Commission will be host a pool party fundraiser at the Brentwood Family Aquatic Complex middle schoolers.
- On July 10, Tiny Tot Triathlon will take place.
- Summer Concert will start on June 17.
- Staff has started to plan for the 4th of July parade.

Joe Odrzywolski, Parks Planner reported the following:

- The City Council voted to change to the name of Trailside Park to Trailview Park at the recent City Council meeting.
- The Vineyard Project is moving along well. As mentioned in a previous meeting, two parks are in the 90-day maintenance period. The construction of Alta Park is moving along; the play structure is installed along with the hardscape, parking lot, and paving stone. They are still working on the irrigation but as soon as that is completed, planting will be go in. There is a delay on the shade structure over the play equipment.
- The Marsh Creek Trail, a mile of the trail is part of the Vineyard Project by Shea Homes, went into construction recently. They have started the grading process. This should take about 30-40 days to complete. Staff may come back to the Commission and ask whether to hold a ribbon cutting when this is complete.

C. NEW BUSINESS

 <u>DISCUSS/ACTION ITEM</u> Discuss and consider approval of Sunset Park Athletic Complex change of hours of operation and any additional relative considerations. (A. Wanden/K. Farro)

Aaron Wanden, Park Maintenance Manager, introduced the agenda item. This was part of the Strategic Initiatives approved by the former City Council. The previous City Council approved for this park to be open from dawn to dusk and with a budget of \$30,000 for prep work and another \$30,000 annually for staff costs to oversee the facility.

Currently, Sunset Park is closed unless there are rentals or for City recreational activities. Staff mentioned that new fencing is installed around the pinwheel (baseball fields 1-4) in preparation of opening up the facility to the public. Unfortunately, there is not enough funding to fence off the soccer fields. The Commission did not think aesthetically fencing about the soccer fields would not look good.

Some concerns brought up by the Commission mentioned:

- a. The Commission worried that once the fields are prep, the public may still play on it or other teams may hold practices on it without a reservation. Staff mentioned that currently when soccer fields are prepped, a-frame signs are placed to let people know the area is not available for use. Would staff be able to monitor the public's use all the time?
- b. Commissioner Peltz knows it takes a lot of time to maintain the high quality of soccer fields we have so it does concern him a bit. Currently, the facility is closed during the winter months to let the fields rest from wear and tear. Would we still be able to do that if we kept the park open year round?
- c. Commissioner Cohen said if users are use to expecting a certain quality of fields but with the opening of the fields, the quality may diminish, would the users continue to rent with us. Could there be a loss of revenue?

Commissioner Lind said she would not like to see any more areas fenced or spending \$125,000 to add more fencing. Vice-Chair would not like to spend that type of money on something that will not look good.

Motion to have staff bring back to City Council to reconsider opening up Sunset Park to the public with hours of dawn to dusk and to keep the process as it is now, through reservation or City use only.
