NOTE: Section 34176.1 ( e ) which states that "... [w]ith respect to interests in real property acquired by the former redevelopment agency before February 1, 2012, the time periods described in Section 33334.16 shall be deemed to have commenced on the date that the [Department of Finance] approved the property as a housing asset." The DOF approved the transfer of all real property holdings, as described in item 4 above, on September 18, 2012.

Per Health and Safety Code 33334.16, the City had until September 18, 2017 to initiate activities consistent with the development of property for low and moderate income housing purposes. Although this date has passed, the City continues to pursue options for development of this parcel for low and moderate income housing purposes. On October 13, 2020 the City Council declared these parcels as surplus, thus allowing for the sale of the properties if Low/Mod use is not able to be arranged. No additional interest in real property has been acquired since September 18, 2012.
