Aaron, I would like to offer some suggestions regarding the Sand Creek Sports Complex:

1. There are no tennis courts included in the design. We only have two parks with each having one tennis court for the entire City of Brentwood. This is outrageous for a city of our size and for a sport that can be played by youth all the way to senior citizens. I highly recommend considering a way to include one tennis court in the design.
2. The current design of the Sand Creek Sports Complex is primarily a soccer complex with a few other features. I find it a stretch to call it a "Sports Complex" as maybe 80-85% of the field space is exclusively for soccer. I highly doubt anyone will be using the soccer fields for lacrosse or baseball/softball practice. Multi-use fields often are dominated by the primary sport and/or sometimes damaged by other use sports, thus reducing use by primary sport. The only other sports included are a couple pickleball courts and two multi-use courts (don't envision the latter being used much). We already have eight parks that have 8-12 soccer fields depending on the configuration. Not to mention the soccer fields available at the local schools. Do we really need another 3-6 soccer fields???
3. The restroom facility being located on the far end of the complex does not seem logical. The restroom should be located in a more central location somewhere maybe closer to the concession building or maybe near the picnic area near the southwest corner of soccer field #3.
4. Food trucks are a popular option for a variety of events. Could the design of the parking lot include some longer dedicated parking spots for food trucks to park? I see some unused space near the southwest corner of the pickleball courts. The trees could be shifted back along the edge of the property line and then create probably 2-3 longer spots parallel to the trees?
